PRESENTATIONS/DELEGATIONS

2021 Wildfire season review

A presentation by R. Donohue, Emergency Program Coordinator, was given regarding an overview of the 2021 Wildfire season.

2021 year had the most amount of fires than any other year - 1617 fires (867,707 Hectors)

Red cross Volunteers were deployed to assist evacuees and Emergency Support Services Surge Team for the remote response. Hilton Whistler registered evacuees from Lyton and Liloett

Take aways from 2021:

- Inter-agency Collaboration needs to be increased for test responses and situational awareness around the roles, responsibilities and capabilities of each agency.
- Emergency Operations Centers staff need more training for an extended state of emergency
- Emergency Support Services requires more online training for evacuations to assist evacuees remotely

The group reviewed and assessed proposed 2021 discussion based training exercises

Chief J. McKearney spoke about Wildfire Deployment

There were two requests to provide certified task force/strike team with type 1 engines. Whistler Fire department shared deployments with Squamish Fire Rescue, where POC's were out for 2 weeks for 12 hours a day in various locations. Positive testimonies of the POC crew were shared.

Logan Lake (Tremont Creek Fire) was given as an example where 1100 properties were effected and 2000 people evacuated. The 10 years of Fire Smart community action proved vital and the pre-determined sprinkling devices, 175 structural and Wildfire firefighters helped.

Lessons to take away from this:

- 10 years of Fire Smart preparedness proved vital
- Capital purchases of water bladders, hoses, sprinklers, external brackets on structures as preventative measures
- Business may have longer shut down procedures to consider

Disaster Preparedness

A presentation by R. Donohue, Emergency Program Coordinator, was given regarding personal preparedness.

BC's top 10 hazards are:

- 1. Floods
- 2. Wildfires
- 3. Earthquake
- 4. Tsunami
- 5. Disease outbreaks

- Rainbow tactical evacuation exercise with ESS team
- 3 WFRS POC deployments for structure protection throughout the provinces
- · EOC exercise for senior staff
- Personal preparedness workshop on Oct 10th for RMOW staff
- WFRS/WB training with snow making crews. Mapping for snow making equipment was taken (thanks given to K. Cailes for the short notice)
- Framework for training exercises
- Working groups with the EPC to develop training and exercises

A further review in the future of hazards and effects of climate change was suggested, as well as increased emphasis on public education (personal and business) emergency preparedness

- T. Battiston questioned if it was just training activities or broader than that. R. Donohue confirmed training one of the aspects at this time and further exercise designs and subgroups were needed to further work towards mitigation.
- J. Ford questioned the cost and substantial time involved. L. Debou confirmed there is no budget in the EPC for these groups, but would look at lead analysis first and then grants in the future.
- G. Cullen supported the need to get into this planning work, with the change of world, more training with the community is required, which can be supported with grants and opportunities

- To engage public while awareness is still high
- E-plan for school district, an iPhone app for key emergency personnel with training on it, to eliminate binder reference.
- · Scenario based training.

More round table discussions for planning and brainstorming are needed going forward was suggested by R. Donohue.
