PRESENTATIONS/DELEGATIONS

Rainbow Park Rejuvenation

M. Pardoe presented two phases of the rejuvenation plans for Rainbow Park.

With regard to Phase 1, the parking, shuttle drop off area, path through the parking area and Valley Trail were discussed:

- 1. Pay parking will not be applied to the accessible parking spots.
- 2. Accessible parking stalls have been increased from two to four stalls.
- 3. A new accessible asphalt sidewalk to/from the new bus drop-off zone on Alta Lake Road has been added.

With regard to Phase 2, the following was discussed:

- 1. Maps showing the main area of the park and the concept plan.
- 2. Hard surface pathway to the water's edge and docks.
- 3. New dock with an accessible water lift.
- 4. Increasing picnicking opportunities.

Valley Trail Design

M. Pardoe made a presentation on the Valley Trail Design Guidelines (VTDG) and review. The following was discussed:

- 1. The VTDG were completed in 2019 to update earlier guidelines. The VTDG document will guide future design.
- 2. The VTDG reflect current considerations and the built environment in a mountain landscape.
- 3. The proposed rest area size does not easily accommodate someone using a mobility device, and it would be ideal to add a rest bench. Staff will revisit this part of the VTDG.
- 4. There are existing accessibility concerns on the Valley Trail, including cars parking on the trail edge at Green Lake and garbage receptacles intruding onto the trail. There are option improvements like line painting and seasonal vertical barriers.
- 5. Criteria used to establish priority in the review were safety, road conditions, cost, crash history, and warning signs.

AIC discussed the following:

- Nicklaus North and Spruce Grove/Nesters crossings are challenging
 for people using mobility devices as they are unable to activate
 pedestrian signals because the traffic islands lack curb cuts. It was
 noted that this is outside the RMOW's jurisdiction, but will be shared
 with the Ministry of Transportation and Infrastructure.
- 2. There are concerns regarding speed on the Valley Trail. It is necessary to communicate speed considerations to the broad range of Valley Trail users.
- 3. There are concerns about the lack of seated rest areas on the Valley Trail.
- 4. There is not enough lighting in certain areas of the Valley Trail.
- 5. There is a need to give consideration to Highway 99 and working with the Ministry of Transportation and Infrastructure to improve the experience for e-bike users along the Highway.

Review of Geo-region Planning

- L. Russell shared a presentation on geo-region planning. The presentation provided a high level overview of the planning process and displayed concept designs and contemplated materials. The presentation discussed the following:
 - The Geopark Society is determining the feasibility of the Geopark and exploring operating models. The goal is to achieve a UNESCO designation.
 - 2. The envisioned Geopark will contribute to long-term economic growth and social well-being of communities throughout the Sea to Sky region.
 - 3. The benefits of establishing the Geopark could assist with reconciliation with Lil'wat Nation and Squamish Nation. Lil'wat Nation and Squamish Nation are involved in the initiative. The UNESCO designation, can bring more opportunity through preservation, conservation and cooperation, and can attract funding.
 - 4. The planning purpose is to provide opportunities to allow all of the stakeholders to express their goals with the project development.
 - 5. Whistler has four potential geosites.

AIC discussed the following:

- 1. The pavers should be large enough and beveled as much as possible to reduce vibration.
- 2. There should be alignment between inclusion and reconciliation and attracting cultural-based tourists to Whistler.
- 3. It is important to integrate low energy lighting, accessible washrooms and rest spots.
- 4. Multi-lingual signage, potentially with QR codes, would allow people with visual impairments to use screen readers as well as provide further information about the site.
- 5. Good educational tourism would be appealing to older adults to both visit the sites as well as be volunteer hosts at the sites. This could also begin some essential conservations about Indigenous heritage.
- 6. Plans to update the Sea to Sky Trail to make it more accessible are seen as a related project.
- 7. The AIC will be able to provide input on the detailed design process.

> It is important to manage potential over-tourism by encouraging people to come by foot and bike. Relatedly, it is essential there is an accessible route to the sites.

OTHER BUSINESS

- 2. Parking at all local grocery stores is on private property.
- There is a need to reach out to businesses to support and promote breastfeeding-friendly spaces and convenience parking for parents of infants and young children.

That AIC receive correspondence from M. Pupo regarding signage to address the public creating barriers on accessible infrastructure in Whistler.

AIC discussed the following:

- 1. There is a need to consider an inventory of bike racks in terms of: are there enough racks; and are they in the right places.
- 2. There is a need to have adequate signage to indicate bike parking is not allowed on ramps.
- 3. Creating a municipal feedback channel on accessibility is an action of the Accessibility Action Plan.
