APPLICANT: Rod Nadeau of Innovation Building Group commented on the following:

 The drawings, as introduced in the original application, clearly illustrate the deck, railings and roof structure. There was never any attempt to conceal or try to hide anything and that this was simply an error made by all the professionals involved with this application. 2. This has caused the Applicant a hardship because in order to get an occupancy permit he requires the variances to be approved.

COMMENTS:

A Board member asked the following questions:

1. Why was the application process not done as a DVP?

The Developer said that the Building Department recommended that the application be taken to the Board of Variance for further discussion.

2. Have the surrounding neighbors been notified?

Staff also confirmed as per the *Local Government Act* s. 541 that all owners and tenants in occupation of the land that is the subject of the application, and the land that is adjacent to that land had been delivered the required notice.

3. A discussion about whether the RMOW is ultimately responsible for approval of drawings was held.
