#### RMOW:

Wildfire Management:

- Contractor returns on October 2 to complete the Millar's Pond fuel thinning project. Some thinning left, and pile burning.
- UBCM confirmed funding for fuel thinning above Brio, and prescription preparation for Kadenwood/Big Timber. Prescriptions being prepared now for Alpine Meadows polygon.
- Fuel thinning projects schedule (dependent on UBCM funding): 2016,
  Brio; 2017, Alpine Meadows; 2018, Kadenwood/Big Timber
- o Callaghan Landscape fuel break continue before year end.

Discussion: RMOW funding needs to be increased to accelerate progress.

Trail Planning Working Group meeting October 8. Trail work continued in 2015, ascent and descent trails to be completed in 2016.

#### **Cheakamus Community Forest:**

CCF logging starting in the fall.

## 6. Access Management Principles

## Subcommittee: Johnny Mikes, Craig Mackenzie, Derek Bonin

J. Mikes presented draft principles. Looking for feedback. Will bring revised version to next FWAC meeting. J. Mikes will be away but can phone in.

Discussion re: target audience for principles. RMOW, CCF or just FWAC? Decision was made to develop for FWAC's use.

J. Mikes will review LRMP, Coordinated Access Management Plan and RMOW referral review list to determine if any aspects can be incorporated. CCF will not be involved in principles development at this time.

#### **OTHER BUSINESS**

**Black Tusk Road & Gate**: RMOW suggested new gate location further up the road. RSTBC responded with concerns and did not support new location. CCF may have to improve road if it logs nearby in future. FWAC is supportive of RMOW's continuing efforts to get the gate relocated.

**Singing Pass Trail**: ACC wants to re-establish the trail and has spoken with FLNRO Resort Planning representative. Request was for car access and parking at IPP. WB not supportive because of safety concerns and suggests parking at Lot 8 and walking up. Another meeting is coming up.

**WIF/Don MacLaurin Sign Project:** Rotary received funding from CFOW. RMOW did a GPS inventory of all signs within WIF. Plan is to create 4 new interpretive signs (Welcome sign; Don MacLaurin commemorative sign; invasive species sign; WIF history sign) and 4 small road side information signs. Graphic designer hired.
