#### **COUNCIL UPDATE**

Update provided by Stephanie Johnson on current Liquor Licence applications including:

- Tourism Whistler has applied for extensions of closing hours for two events during the 2020 Whistler Pride and Ski Festival. Staff anticipate that this item will be on the December 3, 2019 Regular meeting agenda for Council consideration.
- Whistler Cooks Restaurant Inc. (Hunter Gather) located at 101-4368
   Main Street has withdrawn their application to add a patron participation entertainment endorsement to its food primary licence.

#### PRESENTATIONS/DELEGATIONS

LLR1339 Nita Lake Lodge Cure Lounge and Patio Liquor Primary Licence Theresa Ginter, Nita Lake Lodge General Manager outlined the intent of this structural change application to increase the capacity under Cure Lounge's existing Liquor primary licence to allow 30 patrons at the new spa.

A presentation by Stephanie Johnson, Planning Analyst, was given on Nita Lake Lodge (NLL) Management (2013) Ltd. application on a structural change to increase capacity for the Liquor Primary Licence issued to Cure Lounge and Patio at Nita Lake Lodge.

- The spa is currently under renovation through a Building permit
- The Municipal review concluded that Nita Lake Lodge: is in good standing with the Municipality and RCMP, has received an occupancy load stamp by Whistler Fire for 30 persons, conducted public notification (two newspaper ads and a sign at the site for 30 days) and no comments were received, no negative impact to the surrounding community is anticipated
- Based on the Municipal review process staff are recommending that the LLAC support the application

#### **Questions & Answers:**

RCMP Representative: Support. No concerns.

Q. Pub Sector Representative: Could there be a condition that this stays as a spa only? What happens if there is a new owner who uses this licence for another purpose?

- LCRB Representative: No there is no way to specifically say that the licence only works while operating as a spa.
- Resort Experience Staff Representative: Should the spa change to a
  different business this would trigger a Municipality Business licence
  change, which would go through a review process by the RMOW and
  the LCRB.
- NLL Representative: Regarding this space NLL is focused on maintaining the space as a spa facility and see the business model continuing to move in the direction of wellness, there is no doubt that the spa wouldn't be a spa.

Pub Sector Representative: Support.

WCSS Representative: Support.

Restaurant Sector Representative: Support.

Nightclub Sector Representative: Support.

LCRB Representative: Low risk, high reward. Support

Q. LCRB Representative: How will NLL facilitate minors in the spa?

 NLL Representative: The spa at NLL has requested a family endorsement with this licence. Children under 16 will not be permitted in the spa. The primary focus is on a retail spa service and they do not have any foreseeable concerns as they are only planning to have a small fridge for champagne and a glass or two to be consumed by guests.
