CALL TO ORDER

We respect and commit to a deep consideration of their history, culture, stewardship and voice.

ADOPTION OF MINUTES

The minutes from the August 31, 2022 Regular TMAC meeting were deferred to the next meeting.

PRESENTATIONS/DELEGATIONS

Transit Summer Ridership Review E. DalSanto presented the preliminary ridership graphs for the Whistler Transit System, Route 10-Valley Express and Lost Lake Shuttle.

- Daily Average Rides by week over the summer was similar to summer 2019
- Route 10-Valley Express has seen an increase in ridership every year since its inception in 2019, including over the pandemic. This is most likely related to the increase in service hours allocated to this service each year.
- Preliminary observations related to the Pilot Routing for the 10-Valley Express which started on September 6th
 - Millar Creek stops in Function is well utilized as is the Whistler Village stop
 - There were some complaints from passengers on September 6th and 7th but none since.
 - Whistler Transit Ltd is concerned with potential northbound disruptions to schedule at Northlands and Lorimer Road winter afternoons

ACTION 1:

RMOW, Whistler Transit Ltd and BC Transit to come up with a winter operations plan for an alternate northbound route (Village Gate Boulevard to Blackcomb Way to Lorimer Road) during peak congestion as well as a passenger communications plan.

- Preliminary Lost Lake Shuttle ridership data shows fewer rides than 2019 or 2021. However, the counting methodology is different in 2022 and needs to be looked in more detail.
 - Smaller 20 passenger vehicles (as opposed to 70 passenger BC Transit buses) were used in 2022.

ACTION 2:

RMOW staff to review the ridership collection mythology from 2019, 2020 and 2021 to see if there is a better way to compare to 2022.

- Return to Transit Loyalty Program Pass sales Summary up to last week.
 - 6-month and 12-month Pass sales for August and September average around 40, with an average sale of another 60 in October and over 200 in November and December.
 - \circ $\:$ In 2019 we sold a total of 31 12-month passes
 - In August and September 2022, we've sold over 220 6-month passes and over 213 12-month passes
- Ridership recovery around the province is around 80% of 2019

- Whistler's summer free transit pushed ridership above the provincial average
- Squamish saw increases in ridership this summer but not as dramatic as Whistler

BC Transit and Whistler Transit Ltd reported their findings regarding on-time
performance for the fall/summer schedule related to the change to 30 km per
hour in September 2021

- BC Transit has not seen any major challenges to the schedule due to the speed limit change
- Whistler Transit Ltd (WTL) management heard from operators and investigated three areas of concern:
 - Painted Cliff Road from Spearhead Drive to bus stop 102476 at Painted Cliff Turnaround
 - Blackcomb Way from Lorimer Road to Nancy Green Drive
 - Cheakamus Lake Road from Highway 99 to the bridge
- Due to geometry and lack of sidewalk, WTL management and BC Transit agree with the 30 km/hr speed limit on Painted Cliff Road

ACTION 3:

TMAC is requesting that the RMOW consider returning the speed limit to 50 km/hr on Cheakamus Lake Road from Highway 99 (80 km/hour zone) to the bridge (30 km/hour) as well as on Blackcomb Way from Lorimer Road to Nancy Green Drive to assist with on-timer performance (schedule adherence) as well as road design and conditions.

Electronic Fare Program and Policy Update TMAC received an update from BC Transit on the new implementation schedule for UMO and the Electronic Fare Payment Program as well as a memo for TMAC to consider regarding Whistler Fare Policies that need to be updated before UMO is implemented

ACTION 4:

TMAC will review the memo circulated with the September 26, 2022 agenda package and will have a workshop session at the next TMAC meeting in November on Fare Structure and Policies. TMAC is asking that BC Transit bring information regarding the impact on revenue related to recommended policy changes.
