#### PRESENTATIONS/DELEGATIONS

#### Updates

#### RMOW Bylaw Services

A presentation by C. Harkins was given regarding RMOW Bylaw activities and a discussion was held.

- 8 animal attractant calls to bylaw this month, 5 of those were for attractants s around illegal camp sites.
- Ambassador program began last week. Ambassadors will focus on bylaw enforcement in parks and along the Valley Trail.
- S. Gravel called in to meeting at 9:05 am.

#### Conservation Officer Service

A presentation by S. Gravel was given regarding Conservation Officer Service activities and a discussion was held.

- Ongoing issues with bears accessing garbage in Whistler.
- Sow with 2 cubs has been charging off leash dogs around the Nordic area.
- 2 bears recently hit on highway to the north and south of Whistler.
- Callaghan Road is experiencing ongoing issues with people, mostly visitors from abroad, getting out of cars to approach bears.
- Bears have been breaking into locked totes to access garbage in Squamish and Furry Creek. Totes are not bear-proof.

#### AWARE/C2C

A presentation by C. Ruddy was given regarding AWARE and Coast to Cascades activities and a discussion was held.

- Coast to cascades requested that bear specialist, Dr. Lana Ciarniello, review the RMOW's Grizzly Bear Management Strategy
- Dr. Ciarniello reviewed both the Management Strategy and Wind River Hazard Assessment and presented recommendations to the committee of the whole

### RMOW Environmental Stewardship

A presentation by H. Williamson was given regarding RMOW Environmental Stewardship activities and a discussion was held.

- RMOW staff are currently reviewing recommendations made by Dr.
   Ciarniello to determine how they can be incorporated into the Grizzly Bear conflict mitigation strategy and alpine trail risk assessments
- Bear Smart Program Assistant, L. Harrison, will be delivering bear smart messaging at the Lost Lake Discover Nature Booth, Callaghan Camping Festival and two Wednesday Farmers Markets.

#### Council

A presentation by A. DeJong was given regarding Council activities and a discussion was held.
