Bear Related Updates

An update by S. Gravel was provided

- Bear getting into construction bins. COS has addressed this with the company.
- Court case re bear feeding concluded—courts support COS decision. Bear showed unprecedented signs of habituation.
- · COS will continue attractant audits.
- Bear attracted to Earls grease bin. Bins and doors were secured, likely the bear was attracted to the smell.
- Bears are attracted to the open covered area at the Auden museum. Simone requested some thought be put towards solutions for this area.
- Brittany will be returning Sea to Sky COS next season.
- COS (Brittany) and BSPA will pick bear educational sessions at schools next season.

An update by J. Pineda was provided on behalf of RMOW Bylaw Services

 Garbage is increasing at bus stops. Bylaw tries to locate addresses in the garbage to better target education efforts.

An update by A DeJong, was given regarding bear activity at WB:

- Still very low bear activity/movement on WB—although efforts to monitor bear counts could be increased.
- Hopeful that bear viewing at WB will return next season and could be used to collect bear sightings info.

An update by I. Minic-Lukac was provided

• Biking for bears at the golf course for fall was completed. Less bears than in the spring. 1 off-leash dog.

An update by T. Schaufele, was given on RMOW's bear smart program

- Recreational Trails Strategy will be completed in December and presented to the WBAC in the New Year.
- Potential for BSPA and WB to initiate a citizen science program for monitoring on WB.
- COS and RMOW will finalize Riverside campground mgmt. this winter.
- Minimal bear reports throughout the valley

Action Items

 RMOW to include messaging regarding secured garbage allowed on transit via social media. • BSPA will connect with COS in spring regarding educational programs at schools.
