ELECTION SIGNS AND ADVERTISING

Can a candidate or their elector organization or official agent, have campaign signs at the voting place on voting day?

No, there can be no campaign material (signs, buttons, brochures etc.) within 100 metres of a voting place. This includes advance voting opportunities.

Is a permit required for an Election Sign?

Yes. Election Sign Permit Applications are available in this nomination package, on the RMOW website and at the reception desk of RMOW Municipal Hall.

Where can Election Signs be located in the Resort Municipality of Whistler?

Election Signs may be located on private property with the permission of the property owner. Please note that regulations regarding the size, placement and permitted dates for posting election signs apply to those posted on private as well as public property. Refer to the RMOW Sign Bylaw included in this package for details.

What is the Ministry of Transportation and Infrastructure's policy regarding election signs on highway right-of-ways?

The Ministry conditionally allows election signs on highway rights-of-way; refer to the Ministry of Transportation and Infrastructure

Policy.

Contact the Resort Municipality of Whistler (RMOW) Planning Department at 604-935-8170 to submit your application or if you have any questions about your or your candidate's Sign Permit. The information requested in this application is necessary to fully evaluate your request for signs. Completion of this form does not guarantee approval. Candidates must not display signage prior to a Sign Permit approval.

ELECTION SIGN PLACEMENT AND REMOVAL

Signs may be placed on private property or on a municipal road right of way in front of private property, only with the permission of the property owner.

Candidates are not permitted to place signs on municipal, public or government agency buildings or property which has thereon a building or structure or has otherwise been improved by the RMOW which includes but is not limited to parks, playgrounds, boulevards, medians and parking lots.

Candidates are required to remove all signs within 7 days of the election or by-election. Failure to remove all of a candidate's signs may result in forfeiture of the \$200 deposit.

SECTION 6 – SIGNS FOR WHICH PERMIT REQUIRED

6.11 Election Signs

- 6.11.1 Election signs are authorized in all zones, subject to the following regulations:
 - (a) the maximum area of election signs is 2.0m2;
 - (b) the maximum height of election signs is 2.4m2;
 - (c) election signs must not be displayed prior to the date on which an election is called by the relevant election officer:
 - (d) election signs must be removed within seven (7) days of the date of the election in respect of which they were displayed;
 - (e) election signs must not be displayed on private property or on a public right of way immediately adjacent to private property without the express consent of the owner or occupant of the private property.
- 6.11.2 In addition to the sign permit application fee, an applicant for a sign permit for one or more election signs must provide to the Signage Officer security in the amount of \$200.00, payable by cash, cheque or credit card, for the purposes of ensuring the full and timely removal of the permitted sign or signs.

SECTION 8 – GENERAL PROVISIONS & SPECIFICATIONS

- 8.6 Signs on Streets and Other Municipal Property
- 8.6.1 No sign may project into, on or over a street or public property owned or occupied by or under the control of the Municipality including, without limitation, a park, without the express written authority of the Municipality as evidenced by the execution of an encroachment or licence agreement on terms and conditions acceptable to the Municipality from time to time.
- 8.6.2 Council hereby authorizes the Signage Officer to immediately seize and detain any sign unlawfully occupying a street or public property owned or occupied by or under the control of the Municipality.
