  - Subcommittee (S. Adams, M. Douglas, J. Rae) drafted updated & merged CTDS/WCCP
- 5. 2017 Nov/Dec.
  - Presented to ACT; received input from ACT
- 6. 2018 February
  - Sub-committee finalized the updated & merged WCCP/CTDS
- 7. Annually: reviewed & updated by RMOW CP&D and ACT.





# CTDS & WCCP Update & Merge: Outcome

- 1. Title: Whistler's Cultural Plan (WCP)
  - 5 pages; CTDS & WCCP appended.
- 2. Overview clarifies WCP purpose & stakeholder roles.
  - ACH sector success will be built on collaboration.
- 3. Vision & Goals unchanged.
- 4. Strategies: 2 revisions
  - First Nations revitalization & renewal now Strategy #1
  - #9 expanded to: "Showcase Whistler's local artists of all disciplines, natural history, and heritage".
- 5. Recommendations
  - Reduced from 51 (20 CTDS+31 WCCP) to 26; current reality
  - Co-leads; no timelines, operating, or capital implications
  - Adds Cultural Connector Partners
