### General Fire Permit Conditions

I agree that I meet **ALL** of the following conditions for a Fire Permit;

The fire site has a minimum of 3 metres of clearance from dry grass, timber, buildings, decks and any other combustible materials.

The fire site is on a non-combustible surface, such as mineral soil.

Branches from adjacent trees do not overhang the fire site.

A charged hose and a shovel are available, and the hose is capable of reaching all areas of the site.

The Fire Danger Rating at the time of the fire is LOW or MODERATE, as indicated by the BC Wildfire Management Branch Danger Class Website at 3 pm:

Wind speed is less than 20 kilometres per hour.

At least one adult will attend the fire at all times and will completely extinguish the fire.

### **Additional conditions for CAMPFIRES**

I agree that I meet **ALL** of the following conditions for a Fire Permit;

Campfires:

Will be used for a recreational purpose, or by a First Nation for a ceremonial purpose.

Are made of cured solid fuels such as split wood. **Burning uncured yard waste or garden debris is NOT PERMITTED.**

Are no more than one half metre (50 cm or 1.6 feet) in diameter and no more than one half metre (50 cm or 1.6 feet) in height

Are only allowed between 8 a.m. and midnight on any given day.

The CAMPFIRE PERMIT is valid for the calendar year, expiring on December 31st.

### **Liability**

I agree that I am responsible for:

Fire(s) authorized by this permit and any damage(s) to a person or property caused by uncontrolled fire, and

All costs to extinguish a fire, if the permit conditions are violated, including charges and costs of the Whistler Fire Rescue Service and BC Ministry of Forests.

### **Fire Permit**

This application, once submitted, qualifies as my FIRE PERMIT.

The Whistler Fire Rescue Service may inspect the fire site. If the fire site does not pass inspection or the fire site changes, so that it no longer meets all of the conditions, then the FIRE PERMIT becomes invalid.
