### TERMS & CONDITIONS

1. All prior utility billings must be fully paid before automatic payment deductions can begin for the Utility Pre-Authorized Withdrawal Plan.
2. Advance notice of the amount and date of withdrawal will be indicated on the Utility billings. Withdrawals will be made on or after the due dates.
3. For any CHANGES OR CANCELLATIONS to the plan, please advise the Finance Department, in writing, 14 days prior to the next withdrawal date. Change forms may be obtained at [www.whistler.ca/propertytax](http://www.whistler.ca/propertytax) or at Municipal Hall, or notification may be emailed to [paws@whistler.ca](mailto:paws@whistler.ca)
4. It is the responsibility of the property owner to notify the Municipality in writing IF THE PROPERTY IS SOLD, so that participation may be discontinued.
5. A service charge of \$20 will be applied to the utility account for dishonored payments. Penalties will be applied to any outstanding balance after the due date. Missed payments will not be re-presented.
6. A Void cheque or Pre-Authorized Debit Agreement (PAD) agreement from your Canadian financial institution must accompany this application.

**This plan does NOT include property taxes.**

I/We hereby authorize the Resort Municipality of Whistler to debit my/our account as indicated above on or after the Utility due dates as indicated on the Utility invoices. All payments will be made to Resort Municipality of Whistler. Advance notice of the withdrawal amount will be provided on the Utility invoices. I/We have read the terms and conditions (see above).
