#### PRESENTATIONS/DELEGATIONS

# Recreational Trails Strategy

Martin Pardoe, Todd Hallinga and Lorne Russel presented on the Recreational Trails Strategy.

- Research re Species at Risk and Grizzly Habitat considered in development of strategy and trail selection.
- Trails will be assessed against environmental indicators to assess effective building and location.
- T. Schaufele asked if RMOW data from ecosystem monitoring program
  has been considered in the development of the RTS? T. Hallinga
  indicated yes and info from the Priority Habitat Framework as well.
- T. Schaufele asked if seasonal variations will influence trail making decisions and / or spur closures (i.e., trails in heavily impacted areas during heavy rains)? T. Hallinga indicated that bears have been considered but some more thought will be put towards other seasonal variations potentially influencing closures.
- A. DeJong asked if fire risk has been considered for trail building? T.
   Hallinga answered no and that he will explore how they could consider this.
- T. Green asked how the RTS communication strategy processes is working towards RMOW connection with trail forks and all trails? L. Russel indicated that the RMOW has a good relationship with trail forks but needs to work on that with all trails.

## Updates

## Conservation Officer Service (COS)

A presentation by B. Mueller was given regarding the Conservation Officer Service activities and a discussion was held

- Bear activity has reduced but there has still been activity in the village with bears accessing underground parkades to obtain food and grease from restaurants.
- Sow and cubs are thought to have gone into hibernation.

# RMOW Environmental Stewardship

RMOW Environmental A presentation by T. Schaufele was given and a discussion was held.

- Cougar observed in Village. No new reports, thought to have moved on.
- Strategic planning meeting to be held after Senior Mgmt. and council announce changes to committees.
- T. Schaufele will be away during December's meeting. Taylor will chair and Hillary Williamson will step in on behalf of the RMOW and as recording secretary.

# RMOW Bylaw Services

• Bear accessing garbage area under Earls in underground parkade. Staff moved garbage into stairwell with shut door to resolve issue.

 Construction sites have been attractant areas as of late. People walking past are dumping trash into construction bins.

A presentation by A. DeJong was given.

- Upslope Garibaldi Park (approx.. 2200m) there are minimal berries.
- We have had the wettest spring on recorded for 50 years followed by the driest fall on record for 50 years
- Evidence of animals digging into marmot dens, not sure of which animal

A lot of education around Nita Lake after cub and sow issues.
