4.1 Introductions

4.2 BC Wildfire Service Presentation

A presentation by Marc Simpson from BC Wildfire Services on evacuations, zone and Fire Centers and What BCWS does during a fire emergency.

Key notes included

- Why we do evacuations
- Tactical Evacuations
- Evacuation Alerts
- SOLE (State of Local Emergency)
- Evacuation Orders
- Evacuation Rescinds
- Sheltering in Place
- Coastal Fire Centre Jurisdiction Area
 - 16.9 million Hectare area

- Pemberton Zone
 - o 1.1 million Hectare area
 - 3 Municipalities
 - 9 Fire Departments
- Weekly Resource Planning
 - Released Thur-Wed weekly
 - Weather/Fire conditions
 - Number of Fires
 - Request for assistance from other areas
- Spring Outlook
- App for BC Wildfire available for everyone, public included

K. Elliott asked if the province moves as quickly as the EOC during an emergency. M. Simpson confirmed they work in tandem and will react promptly.

- T. Battiston asked why we have the Pemberton station as our nearest emergency base. M. Simpson said the geological boundary was set from historical information such as number of fires and amount of forestry. Other Provincial resources will also be available to support if needed.
- B. Manson asked if the GIS mapping can be shared with the RMOW. M. Simpson said it is accessible, but he can put the technical team in touch with him to have it set up.
- T. Doherty asked is there a notification in place if Pemberton station has to assist elsewhere. M. Simpson said that they will never be completely gone, there will always be help available. The Weekly coordinator at the station is also available to call if information is needed.

4.3 Multimodal Evacuation Plan

Erin Marriner presented the Multimodal Evacuation Plan which included expectations, role and function of the plan

Key notes included:

 - How the RMOW will safely evacuate
- Steering Committee members
- Phases
 - Research and Data
 - Developing a plan to evacuate
- Demographic Data

- Transportation Capacity for evacuation
- Evacuation Modelling
 - 7 Scenarios were developed and assessed
- Range of Evacuation Times
- Evacuation Times by Scenario
- Transportation of People
 - Ride Sharing/Filling empty car seats
- Traffic Management Strategies
- Evacuation Strategies
 - Zoned areas in Whistler
 - Muster points (will be reviewed with the addition of the new #10 bus)
- Evacuation Clearing Time
- J. Hallisey stated that originally this plan was for flooding but has now progressed to accommodate other emergencies such as wildfires
- K. Elliott asked what happens when second homeowners want to come up and grab valuable items. E. Marriner confirmed that the modelling didn't allow for this accommodation.
- V. Cullen asked if during an evacuation if information about not visiting Whistler would be possible. E. Marriner confirm that communication could be shared, and they have firsthand practice of this from when the COVID restrictions were in place.
- T. Battiston asked what the compliance rate would be. E. Marriner said in the modelling it would give a baseline. If there are minors involved, then intervention would be necessary.

4.4 Emergency Program Coordinator Updates

- Training
 - More people are now or have completed Emergency management courses
 - o More capacity for the community to be trained in Emergency
 - Currently accessing free training. Will examine option for grant monies to pay for individual training.
 - Grant applications are being considered if we want to broaden the scope of our management team
- Tabletop Exercise on March 30th
 - Based mainly towards the Fitz debris failure

- 15 attendees
- Grant Purchases for the Emergency Planning Department
 - Water jugs
 - Meals ready to eat packages
 - Water filtration system
- Emergency Program Act
 - The province has delayed it until Fall
- Emergency Preparedness Week
 - Happening May 7th to May 13th
 - Test Alerts will be happening at this time
- J. Ford asked who is allowed to take the courses mentioned. B. Manson confirmed at this time he is recommending any member of the Emergency Planning Committee would be allowed, and to contact him directly. Ted also mentioned that they have done an evaluation within the RMOW to determine who should be doing the necessary courses.
- J. Ford stated that with the new Emergency Preparedness Act that is pending, there will be significant increased emphasis on cooperation between jurisdictions within the region.
- K. Elliott asked after a big emergency event is there any mental health support. B. Manson confirmed there are provincial teams that can come an assist, and there is also a course available that can train and individual to be able to fill that role for our community, but a grant would have to be requested for such course.
- V. Cullen recommended contacting the hotel board association to get them educated on Whistler Alert for members of the public
